BIG, BEAUTIFUL & APPROVED

On July 3, after 29 hours of deliberation that included the longest floor speech and longest vote in the history of the House of Representatives, the One Big Beautiful Bill passed. The House approved the bill 218-214 while the Senate passed the bill 51-50, with Vice President JD Vance casting the tiebreaking vote. This bill creates new forms of tax relief while also extending the Trump tax cuts passed in 2017, which were set to expire this year. The standard tax deduction has been increased by \$750 for individuals and \$1,500 for married couples. This increase will be effective in the 2025 tax year. Additionally. the bill makes the 20% tax deduction for small businesses permanent. It makes significant cuts to Medicaid and SNAP. It allocates \$46.5 border wall construction. It billion for terminates "green energy" manv incentives. Not only will most farmers benefit from the bill's termination of the "death tax." but \$66 billion for farm programs was passed, including changes for ARC and PLC for the 2025 crop year. Payment limits of \$155,000 on ARC and PLC will exist, but LLCs and S corporations will be treated the same as a general partnership.

PESTICIDES PERSIST

Pesticides continue to be a hot legal issue, and this time they are before the Supreme Court. Bayer, owner of Monsanto Co. and maker of Roundup, has asked the Supreme Court to block lawsuits against pesticide manufacturers over alleged health risks. Customers have claimed that glyphosate exposure from Roundup caused cancer, prompting lawsuits under state products liability law. Bayer argues that these claims are invalid under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), which restricts state modifications to pesticide labels. While the Third Circuit has sided with Bayer, the Ninth and Eleventh Circuits have disagreed, creating a circuit split that led this case to the Supreme Court. Now, the Court has asked President Donald Trump's administration for its input on Bayer's request to limit lawsuits claiming Roundup causes cancer

THE CODE

Attorneys wear many hats, and they have many roles that go further than the practice of law. One of the most important roles an attorney has is being an advisor to their clients. Rule 2.1 also allows attorneys to consider moral, economic, social, and political factors when advising clients. PROP 12 CHALLENGE REFUSED

The United States Supreme Court has declined to hear a court case challenging California's Proposition 12. Proposition 12 is a California law that bans the sale of food products from hens and hogs raised in confinement, such as cages or gestation crates. The lawsuit, Iowa **Producers Association** Bonta. challenged Proposition 12 by arguing the law discriminates against out-of-state farmers, gives unfair advantages to California farmers, and imposes excessive burdens on interstate commerce. This decision confirms the law is likely here to stay, unless action is taken by Congress in Washington, D.C.

REAP GRANTS POSTPONED

On June 30, in an unexpected announcement, **USDA** Rural Development office announced the delay in accepting Rural Energy for America Program (REAP) Grant applications. The acceptance period was supposed to open on July 1, the following day. Grant applications will now be accepted starting October 1, 2025. The postponement is supposed to help the USDA catch up with reviewing applications that have already been submitted. Leut Services plans to diligently continue working on applications so that when the October 1 acceptance period opens. we have applications to submit.

SWAMPBUSTER CONSTITUTIONAL

federal judge in Iowa upheld the constitutionality of the wetland conservation program known as Swampbuster. purpose of Swampbuster is to conserve wetlands from being converted into farmland by withholding certain USDA payments. If a farmer converts a designated wetland area into cropland, they are required to pay back certain USDA payments. In this lawsuit, Holdings, USDA. CTMLLC υ. landowners/farmers argued that Swampbuster is unconstitutional under both the Commerce Clause and the Takings Clause of the U.S. Constitution. However, the judge ruled on May 29, that Swampbuster is a valid exercise of Congress's spending power under the Food Security Act because Congress may attach conditions on the receipt of federal funds

THE IMPORTANCE OF RECONCILING

What is reconciling? Why is it important? Both questions are loaded with important answers that everyone who manages a bank account should pay close attention to. Reconciliation has several definitions, but today we are referring to the type of reconciling used in QuickBooks. One of the biggest mistakes people make in QuickBooks is that they don't understand the importance of reconciling, so they don't do it at all. (BIG MISTAKE!) Reconciliation involves analyzing bank statements from the past month to verify the accuracy of the transactions entered into QuickBooks. Reconciling allows you to review past transactions and confirm the date, dollar amount, and categorization. You might be surprised to see how many transactions are duplicated or assigned to the wrong bank account (if you have multiple). Reconciling also helps monitor the flow of money that is coming in and out of your account. It is good practice to reconcile your bank statements and credit cards that are in your QuickBooks file **every month**. An extra precaution is also reconciling your loans quarterly. Some mistakes common that оссиг when combining reconciling are transactions. entering the wrong ending balance, deleting transactions, and incorrect categorization. Do not put off reconciling your accounts until the end of the year. There is enough stress happening then. By getting into the habit of monthly reconciliation, it will eventually become an easier and less dreadful task to do.

BIRD FLU UPDATE

When Secretary of Agriculture Brooke Rollins was sworn in, she worked to implement a five-pronged strategy improve biosecurity on poultry farms and lower egg prices on grocery store shelves. She reports that the strategy has worked to help decrease food prices, with wholesale egg prices dropping 64% and retail prices falling 27% from their peak earlier this year. From January 20 to June 26, 2025, USDA completed 948 total biosecurity assessments on farms across the United States. USDA offers free. voluntary biosecurity assessments to help farmers mitigate HPAI threats. One focuses on wildlife risk while the other focuses on general biosecurity improvements. USDA shares up to 75% of costs to fix the highest-risk biosecurity concerns identified during the assessments. **Farmers** can email

RECIPE OF THE MONTH Fourth of July Crisp

4 cups pretzels
1 ½ cups old-fashioned oats
½ cup flour
½ cup brown sugar
1 tsp baking powder
½ tsp salt
2 sticks salted butter, at room temp
2 tsp vanilla
12 oz jam (any berry, I used blueberry)
½ cup fresh berries (I used strawberries)

Preheat the oven to 350°F. Line a 9x13inch baking dish with parchment paper. Using a food processor, grind the pretzels into a coarse powder. Measure 1 cup of pretzel "flour" and add it to a bowl. Add the oats, ½ cup flour, brown sugar, baking powder, and salt. Add the butter and vanilla. Mix until combined. Press 1/3 of the dough into the bottom of the prepared baking dish. Spread the jam evenly over the dough, then top with berries. Sprinkle the remaining dough over the jam. Bake for 30-40 minutes or until the crumble is golden brown.
